With reference to the above cited subject, as per reference(1) a conditional Fire Safety Recommendation was issued to the premises of **M/s. Mango Valley Public School** situated at Sy.No.26/3 & 26/4, Panasamakalahalli Village, Gundamanatta Cross, Kolar Road, Kasaba Hobli, Srinivasapura Taluk & Kolar District 563 135 with a condition to fulfill the recommendations and compliance the same within 3 months and as per reference (2) the Fire Safety Compliance Report was issued for the same.

With reference cited (4) above, the management of **"M/s Mango Valley Public School"** had requested for the Renewal Fire Safety Compliance Report from our department. In this regard the above school building was re-inspected by Fire Station Officer, Srinivasapura Fire Station on 08-12-2025 and submitted the report & recommended to issue Renewal Fire Safety Compliance Report.



Under the above circumstance the Karnataka State Fire & Emergency Services Department is issuing the **"Renewal Fire Safety Compliance Report"** M/s. **Mango Valley Public School** situated at **Sy.No.26/3 & 26/4, Panasamakalahalli Village, Gundamanatta Cross, Kolar Road, Kasaba Hobli, Srinivasapura Taluk & Kolar District 563 135** subject to proper maintenance of firefighting installations in the good working conditions and arrange for 40% of staffs/employees training within 03 months from the date of issue of this report.

In case the Fire prevention and Fire Fighting measures installed as per the recommendation of the department are not maintained in good working condition, if the evacuation measures are not properly followed and if any additional construction work is taken up in the building/premises, the Fire Safety Compliance Report deemed to be cancelled and necessary legal action will be initiated against the developer/management/tenant and also separate NOC has to be obtained from the department for the storage of chemicals, solvents, petroleum products(Diesel/Petrol). LPG, etc. in the premises/building.

"This Report is Valid up to 10-12-2027 and should be renewed without fail before the validity period".
